

IAMS x Ace Furtastic Contest 2021

1. Rules & Eligibility

1.1. This Contest will be governed by these terms and conditions and details of the **contest (collectively referred to as the “Terms & Conditions”)**. Every participant agrees that these Terms & Conditions have been read and understood and by their participation in the Contest, agrees to be bound by these Terms & Conditions.

1.2. The “Furtastic Contest 2021” is organized by PT. Mars Symbioscience Indonesia. (“Organizer”), which is solely responsible for the execution and management of the Contest.

1.3. Subject to Clause 1.4, the Contest is open to all citizens and residents of Indonesia who are Cat owners and are at least 13 years of age at the time of entry. Participants below the age of eighteen (18) are required to obtain written parental/guardian approval to take part in the Contest, and to provide that to the Organizer on request.

1.4. The Contest is not open to the employees of the Organizer, distributor, advertising and sales promotion agencies and their immediate family members. **“Immediate family members” include any of these: spouse, ex-spouse, de-facto spouse, children or stepchildren (whether natural or by adoption), parent, step-parent, grandparent, uncle, aunt, nephew, niece, brother, sister, step-sibling and first cousins.**

1.5. All personal details submitted must be accurate and complete and subject to proof at the request by the Organizer. The Organizer reserves the right, at any time, to verify the validity of any entry and to disqualify any entry that does not comply with these Terms & Conditions or that interferes with the entry process. The Organizer collects and holds personal details provided by participants in order to conduct the

Contest. The Organizer may disclose such information to third parties, including but not limited to agents, contractors, service providers and offer suppliers. The Organizer is required by law to provide information to law enforcement agencies and government regulatory authorities. Participants should direct any request to access, update or correct information to the Organizer. All entries will become property of the Organizer.

2. Contest Period

2.1. The Contest will run for 33 days starting at 16.00 PM(ID time), 8th Aug 2021 and ending at 11.59 PM, 9th Sept 2021 (**"Contest Period"**).

2.2. Participants are allowed to join the Contest at any time during the Contest Period.

2.3. Proof of purchase is required to join the Contest.

2.4 Any Entries submitted outside the Contest Period will not be accepted.

3. Contest Mechanics

3.1 Each participant is permitted to enter the Contest once only during the Contest Period.

4. Winner Selection

4.1. 10 Winners will be selected by the Organizer from all valid entries submitted after the end of the Contest Period based on the completed submission (1. Fill in the information 2. Submit the proof of purchase (receipt) 3. Submit the photo of moments/hobby with your Cat

4.2. A total of 10 winners will be selected based on the completed submission

4.3. Only entries from individuals will be accepted. Any entry that the Organizer believes has been made (a) via participation in a syndicate and/or (b) via any form of machine-assisted intervention enabling multiple computer-generated entries, will be disqualified. The Organizer reserves the right to reject multiple entries from the same IP address should it deem these entries to be in violation of these Terms & Conditions.

4.4. Any decision by the Organizer is final. No correspondence will be accepted.

6.2. Each winners will verify him/her self via the Facebook direct message, and provide contact and address details to the Organizer. Winner announcements will also be posted on IAMS Indonesia Official Facebook page and IAMS Indonesia website.

6.3. Should a winner fail to complete verification and provide contract and address details within seven (7)days of being contacted, the Organizer reserves the right to disqualify the winner and award the prize to another participant based on the criteria in 4.1 above.

6.4. The Organizer's decision on any matter concerning the Contest is final with respect to any aspect of the Contest, including the determination of the winners. No correspondence or appeals will be entertained.

7. Rights of the Organizer

7.1. Subject to applicable laws and regulations, the Organizer may at its absolute discretion modify, annul or rescind these Terms and Conditions at any time without prior notice.

7.2. If for any reason, any aspect of the Contest is not capable of running as planned, including by reason of infection by computer virus, network failure, bugs, tampering, unauthorized intervention, fraud, technical failures or any causes beyond the control of the Organizer which corrupts or affects the administration, security, fairness, integrity or proper conduct of the Contest, the Organizer reserves the right at its sole discretion to cancel, terminate, modify or suspend the Contest, or invalidate any affected entries.

7.3. The Organizer reserves the right to disqualify incomplete, illegible, disfigured or late entries automatically or when authenticity of an entry is questionable.

7.4. The Organizer may at its sole discretion, disqualify any entries and prohibit further participation in the Contest by any person whom the Organizer reasonably believes has tampered with the entry process or with the operation of the Contest or who has acted in violation of these Terms and Conditions or in a disruptive manner or for any other reason.

7.5. Any Participant who submits an Entry or other material or information which the Organizer reasonably considers is inappropriate for any reason whatsoever, including

but not limited to obscene, illicit or otherwise inappropriate written and/or photo content will be disqualified from the Contest and will not be eligible to win any prizes.

7.6. The Organizer reserves the right to substitute any prize of similar value without prior notice.

7.7. The Organizer reserves the right to select an alternative winner (based on the criteria in 4.1) in the event the Organizer has reasonable grounds for believing that a selected winner has contravened any part of these Terms and Conditions.

7.8. Participants agree to be bound by the decisions of the Organizer.

7.9. The Organizer may require participants to validate single entry in the Contest or to provide more information to allow the Organizer to **verify the participants' entries, at any time during the Contest prior to being eligible to redeem any prize.**

7.10. Acceptance of a prize constitutes permission for the Organizer and its agencies **to use the relevant winner's name, entry and/or photograph for purposes of publicity, advertising and/or trade without further compensation, approval or notice.**
